In this connection, the maturities may be extented in full or on a pro rata basis. The cover pool administrator must extend the maturity for a Prandbrief issue in such a way that the original order of servicing of the Prandbriefe which could be overtaken by the postponement is not changed (prohibition of overtaking).
