| Prerequisites for the extension of maturity of the Pfandbriefe | The extension of the maturity is necessary in order to avoid the imminent insolvency of the Pfandbrief bank with limited business activity, is not overindebted and there is reason to believe that the Pfandbrief bank with limited business activity will be able to meet its liabilities then due after the expiry of the maximum possible extension date, taking into account further possibilities for extension. See also, in addition, section 30 para 2b Pfandbrief Act. | |
| Powers of the cover pool administrator in the event of the extension of maturity of the Pfandbriefe | The cover pool administrator may extend the maturity dates of the principle payments, if the relevant requirements pursuant to section 30 para. 2b Pfandbrief Act are met. The administrator shall determine the period of the extension of the maturity, which may not exceed a period of 12 months, in accordance with necessity. The cover pool administrator may extend the maturity dates of the principal and interest payments falling due within one month after the appointment of the cover pool administrator to the end of that monthly period.
