If the cover pool administrator decides in favor of such a extension of the maturity, the existence of the prerequisites pursuant to section 30 para. 20 Pfandbrief Act shall be irrefutably presumed. Such an extension shall be leaken into account within the maximum extension period of 12 months. The cover pool administrator may only exercise his authority uniformly for all Pfandbrief of an issue. In this connection, the maturities may be extented in full or on a pro rada basis. The cover pool administrator must extend the maturity for a Pfandbrief issue in such a way that the original order of serving of the Pfandbriefe which could be overtaken by the postponement is not changed (prohibition of overtaking).
